## MEMBER WELFARE SCHEME

#### Title of the Scheme

Member Welfare Fund

## Object:

The purpose and object of the '<u>Member Welfare Fund</u>' Scheme is to provide assistance to the 'needy' members of the Bank in their financial difficulties.

## Eligibility:

Bank's regular individual members (shareholder) are eligible for the benefit of the 'Member Welfare Scheme'.

However, a member is eligible for the benefits of the scheme <u>after two years of becoming a</u> <u>member</u>.

#### Nature of Assistance:

i.

The nature of assistance under this scheme is as under:

- a. <u>Sports</u>: A financial assistance shall be given to a member or his / her children on his / her selection and participation in State / National / International level sports. A member seeking assistance under the scheme should submit documentary proof of his / her selection in the sports activity at State / National / International level. <u>The maximum</u> amount of assistance under this category shall be Rs. 10,000/-.
- b. <u>Educational</u>: Awarding cash prizes for SSC & HSC, meritorious children of the members. The eligibility and amount payable under this category is as under:
  - <u>Eligibility</u>: The children of members securing 75% and above marks at SSC and HSC are eligible for cash awards.
  - 2. <u>Amount of Award</u>: The cash prize will be given as under:
    - First 'top ten' students shall get an amount of Rs. 5000 each.
      - If there are more than one number of students having equal marks in first top ten, then they all are eligible for cash award.
    - ii. Above ten students (if any), the other students will be given cash award of Rs. 1000 each.
  - 3. The cash awards will be distributed in the annual function of 'Founders Day'.

- Medical: The benefit under the scheme shall be given as under:
  - 1 <u>Critical Illness</u>: Member <u>above 60 years (Senior Citizen) of age is eligible for</u> <u>maximum assistance upto Rs. 10,000/- under the scheme</u>. Critical illness covers the diseases like cancer, heart disease etc. and any major surgical operation as certified by the doctor;

The concerned member has to submit the medical certificate or documentary evidence for claiming the benefit under this scheme. The payment will be directly made to the concerned hospital.

2 <u>Medical Checkup</u>: The Bank may organise Medical Checkup, eye camp, etc. depending upon the response from members.

# Other Rules:

C.

- a. <u>Only one member from the family</u> is eligible for the benefits under sports & educational category under the scheme;
- b. One member is entitled for the benefits under 'Member Welfare Scheme' once in a year;
- c. The nature of financial assistance and amount under the 'Medical Aid' category shall be at the discretion of the Bank; and
- d. Boards decision in any matter shall be final.
